



## **PORT PIRIE DARTS ASSOCIATION INCORPORATED**

### **BY LAWS, 2023**

#### **1. INTRODUCTION:**

These regulations known as the By-Laws of the Port Pirie Darts Association Incorporated shall be appended to but not form part of the Constitution of the Club.

#### **2. AMMENDMENTS:**

The General Committee may make, amend or repeal any By-Law of the Club by resolution carried at any meeting in accordance with the Rules of the Club. The date of the resolution to make, amend or repeal any By-Law shall be noted within the changed Clause.

#### **3. ANNUAL REVIEW:**

The By-Laws shall be reviewed annually by the executive committee prior to the at the Annual General Meeting of the Club and any changes recommended by the executive committee may be amended or rejected by resolution carried at that meeting in accordance with the Rules of the Club.

A copy of the approved By-Laws shall be placed on the club notice board for members to review.

#### **4. PERIOD OF MEMBERSHIP**

The period of membership for Ordinary, Junior and Associate members shall be for a period of twelve (12) months 1<sup>st</sup> January to 31<sup>st</sup> December each year.

#### **5. MEMBERSHIP FEES:**

(a) The members at the Annual General Meeting have prescribed the membership fees to be:

- Ordinary Members                      \$50.00 per annum
- Junior Members                         \$25.00 per annum
- Life Members (non-playing)        \$ 0.00 per annum
- Life Members (playing)             \$25.00 per annum
- Associate Members                    \$25.00 per annum

Membership fees will be payable on or after the 1st January of each financial year.

(b) Membership fee payable for new Ordinary Members joining the club on or after the 1<sup>st</sup> August of each financial year:

- Ordinary Members        \$25.00

**6. MINIMUM PLAYING AGE OF MEMBERS:**

There shall be no minimum age members to participate in club competitions subject to the following conditions:-

- The Junior player is competent in the sport of darts

**7. JUNIOR MEMBERS:**

Junior Coaching sessions shall to be conducted on a day nominated by the Junior Co-ordinator no age limit applies.

**8. LIFE MEMBERSHIP:**

The members at the Annual General Meeting have prescribed that a club member may be nominated for life membership if they qualify in any one of the following criteria:

- 10 consecutive years as a committee member.
- 10 consecutive years as the Secretary or Treasurer.
- 10 consecutive years as Player of outstanding performance representing the Club.

**9. MINORS ACCESS TO CLUB:**

Minors are permitted entry into the club under parental supervision.

**10. LEVIES AND FEES:**

Prescribed imposed by the Club are the following levies:

**(a) BOARD FEES**

The members at the Annual General Meeting have prescribed the board fees per player to be:

- Board Fees        \$3.00 per match

Board Fees shall be payable for all matches played on Monday and Friday.

All Finals will be exempt of board fees.

**(b) FILL IN PLAYERS – NON MEMBERS**

The members at a meeting of Members have prescribed the following levies:

- Non-Member Fill-in Player    \$5.00 per night

for a maximum of the three (3) nights per membership year. Should the person continue to play more than three (3) they will be required to become an Ordinary Member of the club. The membership fee may be discounted by the amount equal to any levy previously imposed during the membership year.

A Fill in player that is required to become an Ordinary member of the club and then participates in competitions will be subject to clause 5 and clause 6 of the **Rules of Play**.

**11. HONORARIUMS:**

The members at the Annual General Meeting have prescribed the honorariums payable by the Club to the nominated members for duties undertaken for on behalf of all members shall be:

- Treasurer \$500.00 per annum
- Secretary \$250.00 per annum
- Bar Manager \$300.00 per month (\$25.00 per League Session)  
\$50.00 per session (Competition days)
- Kitchen Manager \$300.00 per month (\$25.00 per League Session)
- Kitchen Staff \$50.00 per session (Competition days)
- Cleaner \$300.00 per month (\$25.00 per League Session)  
\$50.00 per session (Competition days)
- Grounds person \$150.00 per month
- Match Coordinator \$ 50.00 per Session

Should any of the following personnel (Bar Manager, Kitchen Manager) be unable to attend on any League night the assistant shall be paid the honorarium for the session and equivalent amount will be deduct from Managers monthly honorarium.

Sessional payment will be paid after the 31<sup>st</sup> October.

**12. EXECUTIVE COMMITTEE:**

The club shall receive nominations for positions on the executive committee for a period of one (1) month prior to the Annual General Meeting.

**13. GENERAL COMMITTEE MEETINGS**

General committee meeting shall be held bi-monthly commencing February each year on the second Tuesday of the month.

**14. LIQUOR LICENSING:**

The committee must comply with the Liquor licensing conditions and ensure:

- (a) Bar staff are required to hold a current Statement of Attainment - Provide responsible service of alcohol. Occasional workers may permitted to serve in the bar under the direct supervision of a certified member of the Bar staff when present in the bar.
- (b) Consumer and Business Services to be notified of changes to the Management Committee with 14 days of the change.
- (c) a copy of the Club license plan is available for inspection by police officers or CBS Inspectors
- (d) the Club Liquor Licence is displayed in the Club foyer.
- (e) mandatory signage is displayed at the main entrances to the Club.
- (f) Bar Management Manual is maintained containing the following information
  - Copy of the Liquor Licensing code
  - Copy of the Liquor License
  - Copy of Bar Staff RSA certificates

## **15. S.A.D.C. JUNIORS REPRESENTATION:**

Any Junior Club Member representing the Port Pirie Darts Association in the S.A.D.C. Juniors State Team shall:-

- (g) attend Junior coaching
- (h) compete in the association championship competitions
  - Club Singles Championship
  - Club Doubles Championship
  - Club Mixed Doubles Championship
- (i) be selected by the Junior Coordinator
- (j) be approved by the Management Committee
- (k) On approval of the Management Committee, the shall:-
  - pay the Responsible Person for the Junior player \$50.00 per vehicle for fuel when attending the tryouts.
  - pay the Responsible Person for the Junior player \$20.00 per day for meals when attending the tryouts.
  - shall have the cost of the playing Uniform and S.A.D.C Affiliation Fee paid by the Club.
- (l) A Junior may apply to the executive committee to obtain an exemption from competing in an association championship competitions under extenuating circumstances.

## **16. STATE AND NATIONAL TEAM REPRESENTATION:**

A Club Member qualifying to be a participant in a State or National competition shall if there is:

- no personal financial gain or expectation of prize money from the event,
- approval of the executive committee,

shall have the cost or part cost as decided by the executive committee of the following expenses - Nomination Fee, Uniform or other competition fees paid by the club.

## **17. COMPETITIONS:**

### **Iron Triangle**

Players competing in the Iron Triangle Competition for Port Pirie are required to be financial members of the Club.

**18. INTERCLUB COMPETITION FUNDING:**

The members at the Annual General Meeting have resolved that funds be provided to the Men's and Ladies Club Captains to be used at their discretion for the purpose of assisting members travel and accommodation costs when attending interclub competitions which shall be:

- Men's Club Captain \$1000.00 per annum
- Ladies Club Captain \$1000.00 per annum

**19. DECEASED MEMBERS:**

If any financial member or a direct relative of that member dies the club will send a card of condolence.

**20. DRESS CODE**

**League Competitions**

Competitors participating in League competitions held by the Port Pirie Darts association are required to wear neat dress, tank tops and singlets are prohibited, open or closed in footwear may be worn.

**Open Competitions**

Competitors participating in open competitions held by the Port Pirie Darts association are required to wear collared shirts and closed in shoes.

**21. HALL HIRE:**

The committee have resolved that the Club Hall may be hired for public functions subject to the following:

**(a) Party Hire**

\$250.00 per event which includes two (2) Bar Staff.  
\$ 50.00 non-refundable deposit.  
Alcohol and Soft drinks to be purchased from the bar.

**(b) Wakes**

\$150.00 per event which includes two (2) Bar Staff.  
\$ 50.00 non-refundable deposit.  
Alcohol and Soft drinks to be purchased from the bar.

**(c) Wakes for a Financial Member, Life Members and Associate Members.**

In the event a Financial Member, Life Member, Associate Members has died the club will provide the members family the use of the facility for free.

The hall shall not be hired for the purpose of conducting 18<sup>th</sup> or 21<sup>st</sup> birthday celebrations.

**22. NATIONAL POLICE CHECK**

All persons who are over 18 years of age that:-

- participate in Junior Coaching Sessions and/or; Cares and/or is responsible for protection of junior members.
- is a member of the management committee.

are required to present a current National Police Check documentation for review by the executive committee.

The executive committee shall review all national police check certificates and will have the authority of the club to decide upon the each person's suitability for the position.

The club secretary will enter the following details of National Police Check certificate in a register:-

- Name
- Address
- Contact phone number
- Expiry date of the certificate

**23. PETROL MONEY:**

The committee have resolved that the petrol money to be paid by members to the drivers of vehicles supplying transport to competition venues shall be:

- Kadina \$10.00 per person
- Port Augusta \$10.00 per person
- Whyalla \$20.00 per person
- Adelaide \$20.00 perperson

**24. PROMOTION**

**(a) Club Logo**

The club logo shall be restricted to use by the club.

The use of the club logo by club members and third parties may only be allowed on the express approval of the management committee.

**(b) Publicity Officer**

The publicity officer shall be responsible communications contact person for club, members and media. To gather and present articles, publications, advertising and promotions of the club as approved by the management.

Comply with the terms outlined in the Duty Statement - Publicity Officer.

**25. SPONSORSHIP**

Sponsors of the club shall be entitled to promote their business on signage within the club.

**(a) Major Sponsor**

The major sponsor is entitled to place a major sign centrally on the dart board wall above the dart boards subject to the following conditions:-

- i. The signage shall have the dimensions 800mm high x 1200mm wide.
- ii. Fee Payable:-

1<sup>st</sup> year the club will purchase the signage to manufactured.  
2<sup>nd</sup> and subsequent years the sponsor shall pay a fee of \$100.00 per annum.

**(b) Board Sponsor**

A board sponsor is entitled to place a sign above a dart board subject to the following conditions:-

- i. The signage shall have the dimensions 600mm high x 800mm wide.
- ii. Fee Payable:-

1<sup>st</sup> year sponsor to pay for the signage to be manufactured.  
2<sup>nd</sup> and subsequent years shall pay a fee of \$80.00 per annum.

Sponsorship fees shall be paid annually for the period of January to December of each calendar year. Sponsorship fees are to be paid by the 1<sup>st</sup> March of each calendar year.

Failure to pay sponsorship by the due date will result in the removal of the sponsors sign without notification. On conclusion of the sponsorship the signage may be retrieved by the sponsor at their expense.

**26. THIRD PARTY SALE OF GOODS**

Sale of goods by third parties goods such as seafood and other goods by club members or visitors is prohibited on club premises.

## 27. TROPHIES

Players must be financial to qualify to receive a trophy.

Competitors playing in league competitions must play a minimum of 1/3 of the games in the current season to be entitled to receive a trophy, medallion or other award presented at the end of year (season) trophy presentations.

Players with the same results for a trophy, the player who has played the most games be given consideration over a player who has played fewer games.

- Ladies Best player per team - (Medal)
- Duffy Memorial Incentive Award - (Trophy)

### (b) Ladies League

- Irving Incentive Award - (Trophy)

### (c) Mens League

- Merv Prior Memorial winners - (Medal)
- Friday League premiers - (Medal)
- Friday League Runner ups - (Medal)
- Highest average Score per team - (Medal)
- Best player per team - (Medal)
- Pepe Memorial Incentive Award - (Trophy)

### (d) Association

- Mens Singles - (Trophy)
- Ladies Singles - (Trophy)
- Mens Doubles - (Trophy)
- Ladies Doubles (Joan Onn) - (Trophy)
- Mixed Doubles - (Trophy)
- Mixed Fours - (Trophy)
- John Onn Memorial – (Trophy)
- Club Person



**(e) Recognition of 180's**

Players achieving a score of 180 will be presented with a 180 badge for each 180 score thrown up to a total of 20 times. After a player has thrown twenty (20) 180 scores the player will be issued a certificate.

**(f) Recognition of 170 Pegouts**

Players achieving a pegout of 170 will have the event registered with the Australian 170 Pegout Club.

Players achieving a pegout of 170 will have the event recorded on the club's 170 pegout shield.

**(g) Trophy Presentation**

The presentation of trophies shall be the duty of the club president at all functions when available.
