



## **PORT PIRIE DARTS ASSOCIATION INCORPORATED**

### **RULES OF PLAY 2023**

#### **1. INTRODUCTION:**

These regulations known as the Rule of Play of the Port Pirie Darts Association Incorporated shall be amended to but not form part of the Constitution of the Club.

#### **2. AMENDMENTS:**

The Club Captain may make, amend or repeal any Rule of Play of the Club after consultation with team Captains and presented to an Executive Committee meeting. The date of the resolution to make, amend or repeal any Rule of Play and shall be noted in the historical summary.

A copy of the approved Rules of Play is to be placed on the club notice board for members to review.

#### **3. SAFETY:**

3.1 All players must wear footwear when playing subject to the following:-

(a) Open footwear is permitted during League nights

(b) Closed in footwear is required for all Invitation and Open competitions attended by visiting teams.

3.2 A player deemed to be a danger to themselves or others within the club will not be permitted to compete.

#### **4. TEAMS:**

4.1 Teams will consist of :

- Monday Mixed Competitions - four (4) or more players as reserve.
- Friday League Nights – four (4) or more players as reserve.

## **5 ROVERS:**

- 5.1 A rover must be a financial Ordinary Member of the club who is not a registered member of a team and has nominated to be a Rover.
- 5.2 If a team is short of a player, the team captain shall notify the match coordinator that a Rover is required to substitute for an absent registered team player, if a Rover is available.
- 5.3 A Rover can play for any team who cannot field a full team in any minor round game.
- 5.4 A Rover may not play if the requiring team stands down a registered team player in favour of a Rover. Refer to Clause 5.2.
- 5.5 In the event that the number of teams requiring a Rover exceeds the number of Rovers available. A ballot will be conducted to allocate the Rovers to a team.
- 5.6 No team can refuse a Rover once requested, and no Rover can refuse a team. If either of these occurs the Rover will cease to become a Rover and the team will be denied a Rover for the remainder of the season.
- 5.7 A Rover may become a registered member of a team on giving notice to the appropriate tournament co-ordinator.
- 5.8 A Rover is not eligible to participate in any final matches.

## **6 FILL-IN PLAYERS:**

- 6.1 Fill-in players are non-financial players who have paid the prescribed levy to participate in a single match. Refer to the **PPDA By-Laws: clause 10**.
- 6.2 If a team is short a player a Fill-in player can be used to substitute for an absent registered team player.
- 6.3 A Fill-in player can play for any team who cannot field a full team in any minor round game.
- 6.4 A Fill-in player may not play if the requiring team stands down a registered team player or refuses a Rover in favour of the Fill-in player. Refer to Clause 5.2.
- 6.5 A Fill-in player may become a registered member of a team on becoming an ordinary member of the Club and giving notice to the appropriate tournament co-ordinator.
- 6.6 A Fill-in player on playing three (3) consecutive games are required to become an ordinary member of the Club. The player on becoming an ordinary member will then be eligible to become a Rover or become a member of a registered team. Subject to **PPDA By-Laws: clause 10**.
- 6.7 A Fill-in player is not eligible to participate in any final matches.

## **7 PLAYER TRANSFERS:**

- 7.1 A player registered with a team at the commencement of the playing season may request a transfer to a different team during the playing season.
- 7.2 A registered player whose transfer request to another team during the playing season that has been approved must forgo and will be restricted from competing in the league in which the transfer occurred, either the Monday Mixed Competition or Friday League Competition for a period of one week.
- 7.3 A registered player whose transfer request to another team during the playing season that has been refused may forgo and will be restricted from competing in the league in which the transfer occurs, either the Monday Mixed Competition, Ladies League Competition or Men's League Competition for a period of two weeks after which they may commence play with another team.
- 7.4 Players may transfer between teams after the close of a playing season but before the commencement of the following playing season with no restriction.

## **8 SCORING:**

- 8.1 The Scorer will have complete control over the game being scored.
- 8.2 If a player asks the Scorer what is left and pegs out on the said amount, it is game shot. If the amount was found to be incorrect the game shot must stand as was stated. If the pegout is missed the score can then be corrected.
- 8.3 Game shot is to be called when the player finishes the leg by hitting the correct double required.
- 8.4 If a player throws their first two (2) darts and busts while scoring or pegging out, they must retrieve their darts and wait for their next turn. If a dart is thrown in disgust or anger the Scorer will award the leg to the other player.

## **9 PLAYING LIST:**

- 9.1 A player list of competing player's names must be placed on the game board by 7:30 pm and once placed on the game board the list cannot be altered.
  - 9.1(a) If a team is short of a player and a player is arriving late, the space may left blank until the player arrives and their name must then be added to the player list.
  - 9.1(b) If a team is short of a player and a player is arriving late, may be added to the player list, but once placed on the list it cannot be removed.
  - 9.1(c) A team short of a player and the player list records any missing player with a stroke, will be acknowledged as a forfeit of that position. Once a stroke is placed on the player list it cannot be removed and replaced with a name.

- 9.1(d) A team shall not start with vacant position if there is a spare registered player present in the hall at the start of play.
- 9.1(e) A team shall not hold a position vacant for a player if there is another registered player of that team available in the hall at the start of play.
- 9.2 The player list must contain the names of all players competing in the match.
- 9.2(a) If a team is short of a player the name of a Rover or Fill-in player may be included in the player list.
- 9.2(b) If a rover is available and present on the club property at 7.30 pm, that player must be used to fill a team in preference to a fill-in player.  
**Penalty:** Breach of rule will result in the loss of three (3) game points.
- 9.2(c) A Rover or Fill-in player cannot be used to substitute for a registered team player who is present on the club property at 7.30 pm.  
**Penalty:** Breach of rule will result in the loss of three (3) game points.
- 9.2(d) A registered player present on the club property prior to 7.30 pm may not be sent away and return after 7.30 pm to enable the substitution of the registered player with a Rover or Fill-in player.  
**Penalty:** Breach of rule will result in the loss of three (3) game points.
- 9.2(e) The Mens league team may use a fifth player to compete in the match, this player must be included on the player list and used in accordance with **clause 20.1**.
- 10. PLAYER CONDUCT:**
- 10.1 While a player is throwing, their opponent must stand at least one (1) metre behind the Oche. Captains have the right to ask people to move from the front of the tables if they are in the way.
- 10.2 Players who are not playing a match shall not use the space between the front table and the Oche line as a walkway.
- 10.3 All players have three (3) minutes to approach the Oche and commence the game.  
**Penalty -** Breach of the rule is forfeiture of the leg.
- 10.4 Any player arriving after the start of a game may compete in the next leg of the match.
- 10.5 Darts are scored by the point of entry of each dart.
- 10.5(a) If the Scorer has counted and stated the dart score to the player and the dart subsequently falls out the score counts.
- 10.5(b) If a dart falls between two (2) other darts and the dart point is touching the board the score shall be counted.
- 10.5(c) If the dart falls out before Scorer has tallied the score or having stated the score to the player that dart score shall not be counted.
- 10.6 No practice darts will be allowed between legs.

- 10.7 A player when the remaining score is less than 170 may request help to count down his score may:-
- while waiting for the opposing player may discuss the scoring down with the team captain or a nominated member of the team.
  - While taking his turn at the oche line must take one complete step back from the line oche line between shots to discuss the scoring down with the team captain or a nominated member of the team.
- 10.8 Each player must ensure his opponent is behind the Oche line before commencing to throw the darts, If the players breaches the rule they shall receive a verbal warning, subsequent breaches will result in the penalty being applied. **Penalty** – Breach of the rule is forfeiture of the leg.

## 11 COMMENCEMENT AND FLOW OF PLAY LEAGUE MATCHES:

- 11.1 Play will commence between 7.30pm and 7.45pm. If there is not enough players present at the start of play the team being short shall forfeit.
- 11.2 The home team will be decided by a toss of a coin and the winner will be deemed to be the Home team.
- 11.3 The home team player will throw the first dart at the Bull in the first match of the night.
- 11.4 Commencement of Singles Matches  
Singles the player to lead off in the first game of a set will be determined by a single dart being thrown by each game participant at the Bull. The player who has the dart closest to the bull shall be the person to lead off in the first game.
- In the second game of each set the player who whose dart was the farthest from the bull in the first game will lead off.
- The lead player of the third game of a set will be determined by a single dart being thrown by each game participant at the Bull.
- The player who was the lead player in the second game shall throw the first dart at the Bull.
- The player who has the dart closest to the bull shall be the person to lead off in the third game.
- 11.5 Commencement of Doubles and Teams Matches  
In doubles and teams games the first participating person named in the list of players of each side will determine the player to lead off in the first game of a set by a single dart being thrown by each nominated player at the Bull. The player who has the dart closest to the bull shall be the person to lead off in the first game.
- In the second game of each set the player who whose dart was the farthest from the bull in the first game will lead off.
- The lead player of the third game of a set will be determined the first participating person named in the list of players to throw at the Bull.
- The player that was the lead player in the second game shall throw the first dart at the Bull. The player who has the dart closest to the bull shall be the person to lead off in the third game.

- 11.6 **Match Order of Play**  
In subsequent matches the home and away teams will take alternate turns to throw the first dart at the bull, in accordance with **clause 11.4 and 11.5.**
- 11.7 **Determination of Bull**  
The Scorer will have the final decision to determine which player has the closest dart to the Bull.
- 11.8 **Play in each leg of set will cease when the peg out on a double has been achieved and the player completing the peg out will be declared the winner of the set. Should the player achieved peg out with two darts and then throw the third dart, the total of all the darts are to be added and the shot will be classed as a “bust.”**
- 11.9 **Maximum Darts**  
The maximum number of darts to be thrown by a player in a leg is 60. When payers have reached the total of 160 darts and on agreement of the team captains, each player of the game shall then throw one dart at the bull with the dart closest to the bull being declared the winning dart of the leg but will not be awarded a peg out.
- 12 MATCH FORFEITS:**  
A team that forfeits a match shall receive no points for the match and the opposing team shall receive a point for each game of the match that was not played.
- 13 SPORTING TRIBUNAL:**  
A sporting tribunal shall be formed to deal with game infringements.  
  
All infringements to be reported to the club captain immediately on the night it occurred.  
  
Monday infringements will be heard Wednesday at 6.30pm.  
Wednesday infringements will be heard Friday at 6.30pm.  
Friday infringements will be heard Monday at 6.30pm.
- 14 QUALIFICATION FOR FINALS:**
- 14.1 A player must play a minimum of 1/3 of the games in the current season to qualify in their current team to play in the finals.
- 14.2 A Rover or Fill-in player who becomes a registered member of a team during a playing season. The qualification games commence from the date of becoming a registered member of the team, any games played prior to becoming a registered member of a team will be excluded from the qualifying tally of games required under **clause 14.1.**
- 14.3 A registered player whose transfer to another team during a playing season-has been approved will forgo any qualifying games played prior to the transfer to the new nominated team. A new period of qualification games will commence from the date of becoming a registered member of the new team as required under **clause 14.1.**
- 14.4 A player of a team who is does not qualify in finals due to unforeseen circumstances may apply to the committee for an exemption to **clause 14.1.**
- 14.5 A Rover or Fill-in player is not eligible to participate in any final matches.

## **15 MATCH RECORDS:**

Match records are to be maintained all matches played within the club to record all player and match statistics.

- 15.1 League match records are to be signed by the team captain or teams representative.  
**Penalty:** Breach of rule will result in the loss of all points won. Forfeited points will be given to the opposing team.

## **16 RECORD OF 180's and 171's**

- 16.1 A record shall be maintained for each registered player who scores either a 180 or a 171 during any league game or Club competitions.
- 16.2 The recording of 180 and 171 scores will cease at the end of the minor rounds.
- 16.3 The recording of 180 and 171 scores thrown after the end of the minor rounds are to be added to each payers tally in the next playing season.
- 16.4 A player who scores the initial 170 score shall have the event registered with the 170 Club of Australia and the fee paid for by the Club.

## **17 PPDA LEAGUE GAMES:**

League matches are the seasonal competitions held by the club and open to the registered members of the club.

### **17.1 Team Registration**

Players prior to the commencement of the playing season are to submit their names to their Team Captain.

Teams Captains shall prior to the commencement of the playing season submit the name of the team and list of registered players to the league co-ordinators.

### **17.2 Premiership Ladder**

Premiership ladders for league competitions are to be placed fortnightly on the club notice board.

### **17.3 Finals Playoffs**

The top four (4) teams of each Monday League and Friday league shall be selected to play off in the A Grade finals.

The bottom four (4) teams of the Friday League shall be selected to play off in the B Grade finals.

## **18 MONDAY MIXED COMPETITION**

Monday Mixed Competition teams shall consist of two (2) male and two (2) female players.

Players will play matches in consecutive order based on the list of players as written on the board.

Doubles will comprise of one (1) male and one (1) female player taking alternate turns the male player is to lead off.

Singles shall be played by alternate male and female players with the first singles being played by the first male player.

Reverse Singles shall be played by alternate male and female players. The home team will lead of the first male player, the away team will play in reverse order with the second male player to lead.

Team game will be played by alternate male and female players with the first male player to lead off.

Monday Mixed Competition will be played in the following format:

- 2 - Doubles (1male & 1female) 601 x 1 set of 3 legs.
- 4 - Singles 501 x 1 set of 3 legs.
- 4 - Reverse Singles 501 x 1 set of 3 legs.
- 1 - Teams game 801 x 1 set of 1 leg.  
Singles are played by alternate male and female players.

Winning team will be the best of eleven (11) games.

Rovers and fill in players of either sex may be used to fill a team when the team is short of players.

## **19 MEN'S LEAGUE**

Men's League competition teams shall consist of teams four (4) players with an optional fifth player.

Players will play matches in consecutive order based on the list of players as written on the board.

Men's League Nights will be played in the following format:

- 2 – Doubles 601 x 1 set of 3 legs.
- 4 – Singles 501 x 1 set of 3 legs.
- 4 – Reverse Singles 501 x 1 set of 3 legs.
- 2 – Reverse Doubles 601 x 1 set of 3 legs.

The reverse singles will be played in the following order of-

player 1 v player 3  
player 2 v player 4.  
player 3 v player 1  
player 4 v player 2

Winning team will be the best of nine (10) games in the event both teams winning five (5) games each the match will be a draw.

Should a draw occur in the finals matches an eleventh (11) game being a teams games of 1001 will be played to determine the winning team.



20.1 **Player Substitution Rule**

The fifth player nominated on the player list prior to the commencement of play may be substituted with another player of the team.

The player to be substituted out must be noted on the player list, along with when the substitution will occur during the match.

**21 PPDA ASSOCIATION COMPETITIONS**

Participants of Association competitions must be financial ordinary members of the Port Pirie Darts Association Incorporated prior to the commencement of the match.

21.1 **Association Shield Competitions**

The Association Shield Competitions shall be held at the commencement of each league season.

- **Merv Prior Memorial Shield (Men's League Competition)**

The Merv Prior Memorial Shield is contested by all the Men's League registered teams. Teams shall comprise of four (4) players.

The competition is knock out event with playing format of:

- Doubles 601 x 1 set of 3 legs.
- Reverse Doubles 601 x 1 set of 3 legs.
- Team Game 801 x 1 set of 1 leg.

Winning team of each match will be the first team to win three (3) games.

- **Elsie Lane Shield (Mixed Fours Competition)**

The Elsie Lane Shield is contested by all the Monday Mixed Fours registered teams. Teams shall comprise of four (4) players (2 males & 2 females),

The competition is knock out event with playing format of:

- Doubles 601 x 1 set of 3 legs.
- Reverse Doubles 601 x 1 set of 3 legs.
- Teams game 801 x 1 set of 1 leg.

Winning team of each match will be the first team to win three (3) games.

### 21.2 **Association Men's Championships**

Association Men's competitions are held annually on a Friday night during the dart season.

All male members who are ordinary members of the Club are eligible to participate in the competition.

- **Men's Singles Association Competition (Danny O'Dea Memorial Shield)**  
Men's Singles Championship is a board round robin competition.
- **Men's Doubles Association Competition**  
Men's Doubles competition is a board round robin competition.

### 21.3 **Association Ladies Championships**

Association Ladies competitions are held annually on a day during the dart season as scheduled by the Ladies Club Captain.

All female members who are ordinary members of the Club are eligible to participate in the competition.

- **Ladies Singles Competition**  
Ladies Singles competition is a board round robin competition.
- **Ladies Doubles Competition (Joan Onn Memorial)**  
Ladies Doubles competition is a board round robin competition.

### 21.4 **Association Mixed Championships**

Association Mixed competitions are held annually on a day during the dart season as scheduled by the Monday League Co-ordinator.

All members who are ordinary members of the Club are eligible to participate in the competition.

- **Mixed Doubles Association Competition**  
Mixed Doubles Championship is a board round robin competition.
- **Mixed Fours Association Competition**  
Mixed Doubles Championship is a board round robin competition.

**22 PPDA INVITATION TOURNAMENTS:** Competitions are open to all dart clubs by invitation to form a team and also teams formed by members of the Port Pirie Darts Association Incorporated prior to the commencement of the match.

- The maximum of teams that may compete is limited sixteen (16) teams due to the hall capacity.
- The completion shall be played over two days Saturday and Sunday with a target completion time of Sunday 6pm.
- Team nomination fee payable \$20.00.

**22.1 Port Pirie Invitational**

The Port Pirie Invitational is a mixed team tournament that is played by teams of four (4) players (2 males & 2 females).

The competition is round robin event with playing format of:

- 2 - Doubles (1male & 1female) 601 x 1 set of 1 leg.
- 4 - Singles 501 x 1 set of 3 legs.
- 1 - Team Game 801 x 1 set of 1 leg.

Winning team will be the team with the highest aggregate of winning games

**22.2 Brian Clark Shield**

The Brian Clark is women's tournament that is played by teams of six (6) female players and a singles championship, held annually on the June long weekend.

**(a) Order of Play.**

The order of play for this competition is as follows:

- Teams played on Saturday and Sunday
- Single played on Monday

**(b) Team competition**

The playing format is round robin event with of:

- 2 - Doubles 601 x 1 set of 3 legs
- 2 – Reverse doubles 601 x 1 set of 3 legs
- 1 – Team Game 801 x 1 set of 1 legs

•

The winning team will be the team with the highest aggregate of winning games

**(c) Singles competition**

Players must compete in the team competition to qualify for the singles event.

Prize money is paid for this event

### 22.3 **Flying Piss Pot**

The Flying Piss Pot is mixed tournament that is played by teams of six (6) players. (3 males and 3 females).

The competition is round robin event with playing format of:

- 3 – Doubles(1male & 1female) 601 x 1 set of 1 legs
- 6 – Singles 501 x 1 set of 1 legs

Singles are played by alternate male and female players.

Winning team will be the team with the highest aggregate of winning games

## 23 **PPDA OPEN TOURNAMENT**

### 23.1(a) **Barry Crawford Shield**

The Barry Crawford competition is open to all dart players who register and pay the appropriate fee.

### 23.1(b) **Barry Crawford Entry Fees.**

- Mixed Doubles played Saturday morning....entry fee \$10.00 per player
- Mens Doubles played Saturday afternoon....entry fee \$10.00 per player
- Ladies Doubles played Saturday afternoon...entry fee \$10.00 per player
- Mens Singles played Sunday morning.....entry fee \$15.00 per player
- Ladies Singles played Sunday morning.....entry fee \$15.00 per player

### 23.1(c) **Order of Play.**

The order of play for this competition is as follows:-

- Mixed Doubles .....Saturday Morning
- Mens Doubles.....Saturday Afternoon
- Ladies Doubles.....Saturday Afternoon
- Mens Singles.....Sunday Morning
- Ladies Singles.....Sunday Morning

### 23.1(d) **Doubles Playing Format**

Board round robin 501 x 1 set of 3 legs.

The team with highest aggregate of wins shall be declared the winner of the competition.

In the case of a draw the team with highest aggregate of legs won shall be declared the winner.

## 23.1(e) **Singles Playing Format**

The playing format for mens singles will be:

Qualifying rounds:  
Board round robin            501 x 1 set of 3 legs.

Preliminary Finals:  
Knock out                      501 x 1 set of 5 legs.

Semi Finals:  
Knock out                      501 x 1 set of 7 legs.

Grand Final:  
Knock out                      501 x 1 set of 9 legs.

The playing format for Ladies singles will be:

Qualifying rounds:  
Board round robin            501 x 1 set of 3 legs.

Preliminary Finals:  
Knock out                      501 x 1 set of 3 legs.

Semi Finals:  
Knock out                      501 x 1 set of 5 legs.

Grand Final:  
Knock out                      501 x 1 set of 7 legs.

## **24 MATCH FORMATS**

### **24.1 ROUND ROBIN**

A Round Robin competition requires each team/player to play against every team/player registered in a competition.

The winner of a round robin competition shall be the team/player who has the highest aggregate number of wins.

#### **Draw Placing**

In the event of a draw placing in a:-

- Singles round robin event draw placing shall have a play off for the position ranking.
- Team round robin event draw placing shall have a count back on the number of legs won by each team. The team with the highest aggregate number legs won will be given the higher ranking and the team with the lower aggregate will be given the next lower ranking.

### **Play Off**

Singles play off for ranking position the following will take effect:

- 1<sup>st</sup> Placing play off  
501 x 1 set of 1 leg.
- 2<sup>nd</sup> / 3<sup>rd</sup> Placing play off  
501 x 1 set of 1 leg.

## **24.2 BOARD ROUND ROBIN**

### **24.2(a) Round Robin Section**

A board round robin is a two part competition consisting of a round robin section followed by a knock-out competition.

The players will be divided by ballot into groups. Each group will play a Round Robin on nominated board/boards to determine a group ranking.

The highest ranking players will progress to Knock-out section of the competition.

The total number of players going through will be a group of either 4, 8, 16, 32 persons.

#### **Draw Placing play off**

Should players have a draw to for a qualification ranking position, a play off for the position the following will take effect.

501 x 1 set of 1 leg.

### **21.2(b) Knock-Out Section**

Player qualifying for the Knock Out will be drawn by ballot for the positions on the schedule of play. The winner of each set will progress to the next round. The loser of each round will be eliminated from the competition.

The playing formats for the knock out matches will be:

- Minor Rounds 501 x 1 set of 3 legs
- Semi Finals 501 x 1 set of 5 legs
- Grand Final 501 x 1 set of 7 legs

## **21.3 KNOCK OUT COMPETITION**

Players will be drawn by ballot for the positions on the schedule of play. The winner of each set will progress to the next round. The loser of each round will be eliminated from the competition.

The playing formats for the knock out matches will be:

- Minor Rounds 501 x 1 set of 3 legs
- Semi Finals 501 x 1 set of 5 legs
- Grand Final 501 x 1 set of 7 legs

## 21.4 **DOUBLE LIFE KNOCK OUT**

Two (2) schedules of play are used with the players being drawn by ballot and recorded on the schedule of play. A separate ballot is to be held for each schedule.

The winner of each set will progress to the next round. The loser of each round will be eliminated from the competition. The elimination process will continue to determine the final player on each schedule.

The winners of each schedule will play off in a Grand Final.

If a player/s win both schedules that player will be declared the winner of the competition, and to determine 2<sup>nd</sup> and 3<sup>rd</sup> positions the runner ups from each schedule of play shall play off. The winner of this play off will hold 2<sup>nd</sup> position and the loser will hold the 3<sup>rd</sup> position.

The playing formats for the knock out matches will be:

- Minor Rounds 501 x 1 set of 3 legs
- Semi Finals 501 x 1 set of 5 legs
- Grand Final 501 x 1 set of 7 legs

## 25 **INTERCLUB COMPETITIONS**

### **Club Representation Selection**

Players selected to represent the club in interclub competitions shall be selected based on performance after reviewing:-

- Player Peg Out average
- Player Score Average
- Player play positions in teams and level of opposition players
- Player availability
- Team compatibility

### **Team Selectors**

#### **Ladies Competitions**

Teams shall be selected by the Ladies Club Captain.

#### **Mens Competitions**

Teams shall be selected by the Mens Club Captain.

#### **Country Championship**

The Country Championship team shall be selected by a committee consisting of the Mens Club Captain, Monday Night Co-ordinator and the Country Team Captain.

### **Ladies Competitions**

The ladies competitions approved by the committee in which club members participate, and where necessary will have the accommodation subsidised are:-

#### **Annie Raymond**

The Annie Raymond is an annual Ladies team competition held by the Kadina Dart Club.

Teams comprise of 4 players.

#### **Carol Veart Memorial**

The Carol Veart is an annual Ladies team competition held by the Whyalla Ladies Associated Darts.

Teams comprise of 4 players.

#### **Dot Voakes**
